### **Information about on-line reservation services**

The on-line reservation service on the [www.maggiore.it](http://www.maggiore.it) website is a safe and easy way to ensure vehicle availability at a guaranteed price. Clients may also book through the Reservation Center (tel. 199 151 120) during opening hours. The rates which are valid at the moment of reservation shall be guaranteed when the Client signs the Rental Agreement, which completes the contract. Until that time no information or content has any sort of contractual significance.

The Client shall provide correct and truthful information, as well as report any changes in information regarding reservations and consequent rental, which may only take place if all of the requirements listed in the General Conditions have been met.

Maggiore reserves the right to refuse any reservation at its own discretion and it shall contact the Client requesting the reservation (by e-mail, fax or telephone) to notify him/her of reservation non-availability.

The reservation procedure ends when the client is assigned a reservation number and an email or fax is sent confirming the details of the service and listing the reservation number which is required at the moment of rental.

If the vehicle is reserved in the name of more than one person, payment of the full amount and all responsibility falls to the individual who signed the Rental Agreement.

The terms and conditions of the reservation and reservation simulation service may be changed at any time. Maggiore would also like to inform you that the applicable General Conditions are those which are valid at the moment the Rental Agreement is signed and not those valid at the moment of Reservation.

Rate information provided by the service is based on the information provided by the Client. The official Maggiore website contains a list of the reservation and rental conditions for Maggiore vehicles, which is also provided in English. The Rental Agreement is drawn up at the moment the Client picks up the vehicle and signs the Agreement in approval of the General Conditions.
